

# Health and Safety Advisory: Beyond Broadway LLC (DBA LivWell)

**October 12, 2022** — The Colorado Department of Revenue (DOR), in conjunction with the Colorado Department of Public Health and Environment (CDPHE), is issuing a health and safety advisory due to the identification of potentially unsafe levels of Total Yeast and Mold contamination in Medical Marijuana flower (bud/shake/trim) produced by **Beyond Broadway LLC (DBA LivWell)**. The CDPHE and DOR deem it a threat to public health and safety when marijuana is found to contain levels of Total Yeast and Mold above the acceptable limits established in <u>Colorado Marijuana Rule 4-115</u>.

Through an investigation, the DOR has identified Medical Marijuana flower (bud/shake/trim) from packages derived from a Harvest Batch produced by Beyond Broadway LLC that contained levels of contaminants above acceptable limits for Total Yeast and Mold or were determined to be potentially contaminated. Packages were sold from the following Medical Marijuana Stores between July 28 and August 22, 2022:

- LivWell I LLC Medical Marijuana Store (402-00903) located at 2647 8th Ave., Unit B, Garden City, CO,
- LivWell II LLC Medical Marijuana Store (402-00894) located at 570 North Murray Blvd., Colorado Springs, CO,
- LivWell III LLC Medical Marijuana Store (402-00666) located at 1941 West Evans Ave. in Denver, CO,
- LivWell VII LLC Medical Marijuana Store (402-00837) located at 900 North College Ave. in Fort Collins, CO,
- LivWell X LLC Medical Marijuana Store (402-0100) located at 1015 2nd St., Berthoud, CO, and
- White Mountain Medicine LLC Medical Marijuana Store (402-00618) located at 3234 North Nevada Avenue in Colorado Springs, CO.

Consumers who have this affected marijuana in their possession should destroy it or return it to the Medical Marijuana Store from which it was purchased for proper disposal. Consumers who experience adverse health effects from consuming the marijuana flower should seek medical attention immediately and report the event to the Marijuana Enforcement Division by submitting a <u>MED Reporting Form</u>.

All affected marijuana has a label affixed to the container that, at a minimum, indicates the license number of the Regulated Marijuana Business that cultivated the marijuana and the Harvest Batch number assigned to the marijuana. Consumers should check the label of their Medical Marijuana flower for the following Medical Marijuana Cultivation license number, Harvest Batch number, and package tag numbers.
