



Health and Safety Advisory: SLOW BURN FARMS, LLC

Aug. 30, 2024 – The Colorado Department of Revenue (DOR), in conjunction with the Colorado Department of Public Health and Environment (CDPHE), is issuing a Health and Safety Advisory due to the identification of contaminated Retail Pre-Rolled Marijuana produced by **SLOW BURN FARMS, LLC**.

The CDPHE and DOR deem it a threat to public health and safety when marijuana is found to have Aspergillus and the pesticide Thiabendazole levels above acceptable limits established in [Colorado Marijuana Rule 4-115](#). This advisory includes Production Batches that were tested and were found to have exceeded acceptable limits.

SLOW BURN FARMS, LLC collaborated with the Marijuana Enforcement Division (MED) to initiate a voluntary recall for the affected Production Batches. The affected product is listed below (by license number and Production Batch) and was sold between **Feb. 8, 2024**, and **July 22, 2024**. The store locations that sold the affected product are also included below.

Individuals who possess this affected marijuana should destroy it or return it to the store from which it was purchased for proper disposal. Individuals who experience adverse health effects after consuming the product should seek medical attention immediately and report the event to MED by submitting a [MED Reporting Form](#).

All affected Pre-Rolled Marijuana has a label affixed to its container that, at a minimum, indicates the license number of the Regulated Marijuana Business that manufactured the Pre-Rolled Marijuana, as well as the Production Batch number assigned to the Pre-Rolled Marijuana. Consumers should check the label of their container of Retail Pre-rolled Marijuana for the following license numbers and Production Batch numbers.
