#### HB19-1230 ("MARIJUANA HOSPITALITY ESTABLISHMENTS")

The Colorado Department of Revenue's Marijuana Enforcement Division (CDOR MED) is facilitating the following stakeholder work group to provide an opportunity for stakeholder collaboration on the implementation details of **House Bill 19-1230 ("Marijuana Hospitality Establishments")**, to include proposed rules, forms, and process updates.
